#### 1. PRESENTATIONS

- 1. Mike Feuer, City of Los Angeles City Attorney, will present his plan for homelessness and answer questions about his office and issues facing the City.
- 2. Rubina Ghazarian, City Planning, The City of Los Angeles is in the process of updating the Transportation Demand Management ordinance, which was adopted in 1993. The update will include context-based, project-specific strategies to increase equitable and multimodal access to goods and services. Over time, additional strategies can be included as transportation technologies and innovations emerge. The ordinance update will help implement Mayor Garcetti's sustainability goals to fight climate change and create a more resilient City. The City of Los Angeles is also proposing a series of minor ordinance revisions to align procedural sections of the Code and Specific Plan terminology with the Mobility Plan 2035.
- 3. Amit Thakar, LawMaker, Council Member Ryu is challenging all LA residents, not just his own constituents, to propose and crowdsource new ideas for how we can make City operations more transparent and accessible. On December 11, the policy with the most support on LawMaker will be selected by his office to create a new city program or piece of legislation to make LA government more accessible and accountable to residents like us. This is an historic opportunity for Angelenos to actually have a direct impact on the crafting of a new law or program that will impact each and every one of us.
