Discussion and possible action for the Los Angeles Neighborhood Council Coalition (XXXXXX Neighborhood Council) is gravely concerned that it has taken 2 years since the Los Angeles Neighborhood Council Coalition asked for Councilmember Jose Huizar to resign that the Los Angeles Times Editorial Board, Mayor Garcetti, Council President Martinez, and Controller Ron Galperin have asked him to step down. It is offensive that Mr. Huizar is allowed to collect a paycheck during these times, when Angelenos do not have jobs because of COVID-19 and the current riots, from the taxpayers while not having to attend committee or council meetings and represent the good people of Council District 14. Mr. Huizar, do the right thing for the people of Los Angeles and RESIGN.
- 7. Discussion and possible action for the Los Angeles Neighborhood Council Coalition (XXXXXX Neighborhood Council) is gravely concerned that Eric Garcetti has been in office for 19 years, with 14 years as Council President and Mayor, and on Thursday, June 4, 2020 you announced that this was a moment that we must seize to take action to end the scourge of racism. You have had 19 years as an elected official to correct racial injustice in the City of Los Angeles and you have failed us and your words fall on deaf ears. While rioters and looters were destroying and burning our business districts, you did not stand up for those business owners and hardworking employees who businesses and jobs were destroyed and livelihoods crushed. Just like in 1992, many of these businesses will not come back depriving residents of vital services and employment opportunities. You and the other elected official, who for years have known that this powder keg was ready to explode need to feel the pain on all Angelenos. We demand that all elected official in the City of Los Angeles take a 46% pay cut so that you can feel the pain and injustices that Angelenos have felt for your lack of leadership that gotten to this point of despair and unrest.

Without a tangible list of cuts to review, we cannot support the reduction at this time. Depending on the cut, it could reduce community policing in the areas that could not afford private security and cause an increase in crime.
