<u>19-0600</u> Fiscal Year 2019-20 Budget Proposal, including the NC Budget Advocates White Paper positions

New Motions or Reports since last VANC meeting:

- <u>19-0046</u> **To Rules, Elections, and Intergovernmental Relations Committee** Motion (Ryu - Krekorian - et al. - Wesson, Jr.) - Request the City Attorney, in consultation with City Ethics Commission staff, prepare and present a draft Ordinance to prohibit contributions to City elected officials and candidates for City office from developers seeking City approvals for potentially lucrative projects.
- <u>19-0002-38</u> **To Rules, Elections, and Intergovernmental Relations Committee** Resolution (Koretz - Harris-Dawson) - Resolve that the City hereby includes in its 2019-20 State Legislative Program its position to SB 50 (Weiner), which would allow construction of higher density multi-family housing developments near major transit stops that are out-of-compliance with local land use regulations and procedures, unless amended to exclude the City from its provisions.
