3. RAISE LA (HOTEL LIVING WAGE POLICY) ---Ed Gutierrez, Senior Researcher for LAANE and Rachel Torres, from Alliance for a New Economy

RAISE LA POLICY

This is a specific policy for raising the minimum wage of hotel workers to \$15.00 an hour. These workers must work in hotels with 100 rooms or more in the city of L.A. (Not the County).

This policy will impact a projected number of about 9,000 workers in the city of L.A.

Other legislation that this policy includes to protect the rights of workers are:

- An annual cost of living adjustment of either 2% or the consumer price index whichever one is greater.
- · A minimum of 5-paid sick-days per year
- Workers who perform services are to receive their tips that they have earned and are left for them. According to the presenters hotel workers don't receive their earned tips; the management keeps a portion or all of their tips after they have reached their quota. "It is for this reason that there needs to be legislation to protect the workers," stated the presenter.

The hospitality industry is the backbone of the tourism industry. It is profitable, growing, and highly subsidized by city tax dollars. "The city support is making hotels successful," said the speaker. Yet it has a large concentration of low-wage workers living below the poverty line. Statistics gathered in a study done by the non-profit Economic Policy Institute found that 43% of hospitality workers in the city of L.A. are earning below the poverty line, making it one of the largest low-wage sectors in the city. More than half of LA's hotel workforce, 89% in the housekeeper category is made up of Latino women who are raising children.

In the last 10 years between hotel development tax breaks, subsidies, and the money to promote tourism, almost a Billion dollars was put out by he city in making sure that the Hotel industry continued to thrive. Yet, many hotel workers qualified for a variety of public assistance programs such as: Med-Cal, WIC, Head Start, Cal Fresh (food Stamps), Housing and Family Assistance. "One of the most successful industries in our city is providing corporate welfare while taxpayers foot the bill," said the speaker. "We can't really tell what exact number of these workers are enrolled in these programs, but they do qualify by their earned wages of about \$10/hour for women with children."

This year the room cost was raised, but workers wages stayed the same. Workers are forced to clean more than 20 rooms in a single shift. This push has resulted in the increase of injuries of hotel housekeepers that keep them away from work; they rank in the top 10 out of the 800 professions in workplace injuries as tracked by the Bureau of Labor Statistics.

The majority of the hotel owners are based outside of L.A. creating an impact on the economy of the city; "Hotels are owned by real estate investment firms and larger corporations situated in other cities, so this money gets shifted out to other places and does not stay here," said Rachel.

LANCC members voiced objections to this Policy

A LANCC member stated that she did not support this policy because these wage earners send their money to Mexico. Another member sated that it wouldn't be fair to raise hotel workers' wages and not the other wage earners who work just as hard.

Moved that the Los Angeles City Council and the Los Angeles City Controller institute an audit of the Los Angeles Housing Department for the purposes of identifying all low [income] and affordable housing units that should be registered, are actually registered. In a random West L.A. audit, it was discovered that there are only 28 units of low [income] or affordable housing registered. Based on the WLANC resolutions approving SB1818 developments in their district, it is apparent that the total number of units [affordable for low income that were demolished] does not match the number of units built, thereby affording developers have an unfair profit on units designated for low [income] or affordable housing.

Motion 2

Moved that the Los Angeles City Council and the Los Angeles City Controller institute an audit of the Los Angeles Housing Department for the purposes of identifying all rental units designated under the Rent Stabilization Ordinance are actually registered. In a random West L.A. audit, it was discovered that many units that were covered under the Rent Stabilization Ordinance have been demolished and replaced with newer units in larger numbers on the same parcel of land. Under the law, every parcel demolished and rebuilt as rental units are still subject to the Rent Stabilization Ordinance. It is noted that it is done by the parcel not by the number of units demolished. Many units in the West L.A.N.C. district are in violation, as they are not posting [the required RSO certificate] in [at the entrance of] the buildings as required by law, nor can they be verified as rent control units.
