 - a. We are requesting DONE to provide a **"ready to purchase shopping list"** which would be city services vetted by the city clerk's funding dept and provide all necessary paperwork. Items such as:
 - Pothole repair
 - Creation/Installation of Neighborhood Watch Signs
 - Tree purchase
 - Restricted parking
 - Speed bumps
 - b) Requesting a **direct phone list/email** list for LA City department heads and chiefs of staff for elected officials
 - c) Requesting a message that NCs email/phone calls have been received
 - d) Return to \$50,000 **budget, increased** to \$81,000 for inflation
 - a) **After 20 years,** we're still trying to educate our communities on who/what Neighborhood Councils are, why?
 - b) How has DONE empowered NCs?

MISSION:

To identify problems and help develop solutions to issues of concern to Neighborhood Councils in the Valley and throughout the City,

- To promote Neighborhood Council informed participation in the political process regarding local, regional and City issues,
- To advocate before City Council, Council Committees, DONE, and BONC as **one** voice on issues that affect the City and Neighborhood Councils.

GOALS

- To make Neighborhood Councils more effective at each level of organization,
- To act as a clearinghouse and resource center on Neighborhood Council and City of Los Angeles issues,
- To offer a forum for dialogue with elected officials and department heads,
- To encourage involvement of stakeholders in the neighborhood council process through effective outreach,
- To conduct ongoing research, discussion, and education.
